## MICHIGAN'S LARGEST REAL ESTATE SHOW GIVEAWAY: TERMS AND CONDITIONS ("aka OFFICIAL RULES")

These Terms and Conditions ("Agreement") govern participation in Michigan's Largest Real Estate Show ("MLRES") in Michigan prize giveaway (the "Giveaway"), sponsored by Michigan's Largest Real Estate Show, LLC. ("MLRES"/the "Sponsor"), with an address of <u>63139 Turnberry Way, Washington Twp, Michigan 48095</u>. This Giveaway is solely intended to promote the show in Michigan and does not promote any specific real estate property or development. By entering or participating in the Giveaway, you ("Participant") agree to be legally bound by the following terms and conditions (aka "Official Rules"):

**SPONSOR**: Michigan's Largest Real Estate Show, LLC.

**NO PURCHASE NECESSARY**: Admission to Michigan's Largest Real Estate Show in Michigan requires the purchase of a ticket (\$12.00 for adults, free for children under 10), no additional purchase or real estate transaction is required. Upon arrival at the event, participants who purchase a ticket in support of the show may also complete the necessary form and will receive one (1) ticket, which serves as their official entry into the drawing. Tickets for the drawing are limited to one per person and must be obtained at the event during event hours unless registration for the drawing is made online. In person tickets cannot be obtained or purchased in advance or after the promotion period. **CONDUCT**: By participating in the Giveaway, entrants agree to be bound by these Official Rules and the decisions of the Sponsor which shall be final and binding in all respects. - Arbitration shall take place in Oakland County, Michigan.
